SECTION 5: Fire-fighting measures

5.1. Suitable (and unsuitable) extinguishing media

- Suitable extinguishing media : dry chemical powder, alcohol-resistant foam, carbon dioxide (CO₂).
Unsuitable extinguishing media : Do not use a heavy water stream.

- Fire hazard : vapors may cause fire/explosion if source of ignition is present. Watch out for invisible flames.

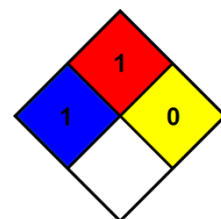
